## 2. Conditions of validity:

**This certificate replaces the certificate Reg. No. 258/04/06/05/0.**

This certificate is valid for ten years from the day of issue and may be renewed upon request.

Modifications of the pressure equipment against the certified one shall be immediately reported to TÜV SÜD Czech. This circumstance may cause the future continuation of the certificate to depend on additional evaluation of conformity.

The relevant directions for use and installation shall be added to each product.

Each product shall contain an explicit reference to the manufacturer or importer and the type designation to allow for determination of identity of the tested type with products put into circulation.

## 3. Rules for certificate handling:

The certificate applies to the products only that are specified on page one. This applies also to its utilization in promotional, advertising and commercial documents.

This certificate may be reproduced only as a whole. It is forbidden to amend, complete or change the data in the certificate.

Unauthorized or deceptive use of the certificate may be fined (§ 19 of Act No. 22/1997 Coll. as subsequently amended by Act No. 71/2000 Coll.).

The certificate does not apply to products that were changed without consent of TÜV SÜD Czech, with the change affecting the conformity with standards and regulations used.

The certificate applies only to its holder and to products and places of manufacture specified in it. It is not allowed the certificate to be transferred by its holder to third persons and/or to be used by third persons. It may be transferred to third subjects only by TÜV SÜD Czech.
